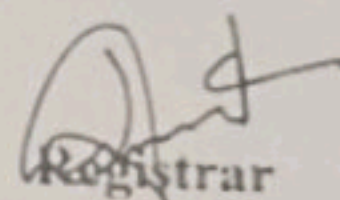

(The term of the office members other than Ex-Officio members, shall be three years from the date of their appointment and they shall be eligible for reappointment.)

1. The Building & works Committee shall have the following Powers and functions, namely:

- a. Carry out construction of all major works;
 - b. Give necessary administrative approval and expenditure sanction for minor works and works pertaining to repair and maintenance within the approved budget provision of the University;
 - c. Cause to prepare cost estimates for buildings and other capital works, minor works, repair, maintenance and the like;
 - d. Be responsible for making technical scrutiny of the design, estimates and specifications of the material as may be considered necessary.
 - e. Be responsible for enlistment of suitable contractors and acceptance of tenders and shall have the power to issue directions for departmental work where necessary; and
 - f. Have the powers to settle rates not covered by tender and settle all disputes and claims with any group or persons/contractors.
2. If, in the opinion of the chairperson of the Building and Works Committee, any emergency has arisen which require immediate action to be taken, he shall take such action and report the same to the Building & Works Committee and the Board of Governors at their next meeting.
 3. The building & Works Committee shall also perform such functions and exercise such powers as may be entrusted by the Board of Governors, from time to time.
