Select the Program Name from the dropdown list in which you want to apply. Enter Applicant Name, Father Name, Valid email id. and Click on “Verify Email” button to verify your email. An OTP will be sent on your registered email id. Enter the received OTP in the text box and click on Verify button to verify email id. Enter your alive mobile number and insert Captcha code then click on the “Register” Button to make your registration. A message of “Successfully Registered! Please go to registered email address or phone number for getting password. After Successful registration username and password will be sent to you on the registered email id. First time it will open directly. You will be required to write down your credentials for future login.

Step 2: Login:

Enter your credentials to login.

Step 1.1: Guideline's: Read all guidelines, and click to Next

Step 1.2: fill Personal details in “Personal Information”. *All the fields marked with an * sign are mandatory.*

- (a) **Applicant's Name** : Name of the candidate as filled up during the registration will appear automatically.
- (b) **Name as it appear on Xth / XIIth Marksheet / Graduate Marksheet** : Write your name as it appears in your Xth / XIIth Marksheet / Graduate Marksheet issued by the Board/University.
- (c) **Father's name**: Write your father's name in capital letters as it appears in your 10th certificate or first Board/University Examination certificate.
- (d) **Email**: Email Id as filled by the applicant during the registration will appear automatically.
- (e) **Mother's name**: Write your mother's name in capital letters as it appears in your 10th certificate or first Board/University Examination Certificate.
- (f) **Blood Group**: Select the blood group from the dropdown list.

(Note: If the candidate wants to edit the application form, click on “Previous” Button. The candidate can edit his/her information in the application. After making the payment, the candidate will not be able to edit his/her application form.

Step 1.5: Payment: To make the payment candidate have to select Online Payment radio button against Payment Mode and click on Pay Using HDFC button. The page will redirect to the payment gateway.
