- The students shall have to pay institution fee as notified by the State Govt. from time
- The University will charge Rs. 50,000/- (One time) as course continuation fee from all such students to meet out various expenses of the University. 5

Technical University Campus at Daruhi. There is a huge infrastructure built for this institute for running five diploma courses in Engineering. But at present only two courses are running since 2007 and lot of space is underutilized. Therefore to begin with, HPTU can liaison with the Department of Technical Education, Himachal Pradesh to utilize this spare infrastructure for its Off Campus.

The Academic Council also approved that when suitable pieces of land are available and acquired at or nearby Palampur, and Banikhet, these Off Campuses will be established as a full-fledged College of HPTU."
